AEI FEE INFORMATION

The AEI cannot accept credit card payments. If you are outside the United States, your check for the application and express-mail fees must have a computerized bank code and routing numbers and must be payable through a U.S. bank in U.S. dollars. If you do not wish to pay the express-mail fee, it may take 4 to 6 weeks for your acceptance documents to reach you in your home country. Payment of all fees on registration day must be made with traveler's checks, cash, an international check drawn on a U.S. bank, or your personal check. If you register after the registration date indicated, you must also pay a \$50.00 late registration fee. All fees paid are non-refundable.

HEALTH INSURANCE INFORMATION

The required AEI group insurance coverage for those students with an F-1 visa will begin when your AEI fees are paid at the time of registration. Health insurance coverage purchased in your home country cannot be substituted for the mandatory health insurance plan provided by the AEI. The AEI recommends that you have additional health insurance that will cover the time period from when you leave your country to when you register at the AEI.

SEVIS I-901 FEE

All new AEI students with I-20s marked for "initial attendance" must complete Form I-901 and pay a SEVIS fee before making an appointment to obtain a student visa. This fee is not payable to the AEI. Additional information about how to pay this fee will be sent to you with your AEI acceptance documents.
